REFUND/CANCELLATION POLICY:

If written cancellation is received by Executours by the date(s) specified below, refunds and cancellation penalties are:

By Sept. 25, 2010 - refund of trip deposit less \$300 per person.

By Oct. 23, 2010 - refund of trip deposit less \$500 per person.

By Nov. 20, 2010 - refund of trip deposit less \$1,500 per person.

After Nov. 20, 2010 - no refund.

Travel insurance payment is non-refundable.

Executours Travel strongly encourages you to purchase travel insurance. Prices are listed on the brochure. Travel insurance can be bought at time of deposit and must be bought before final payment is due for the tour. Coverage, terms, exclusions, and limits are governed by the coverage documents, which are controlling.

Additional Terms & Conditions

RIGHT TO CHANGE TOUR LEADER: Should Dr. Creasy be unable to lead all/part of the tour for any reason, another tour leader may be substituted in his place without notice. There will be no refunds or credits.

AIR TRANSPORTATION: Round-trip economy group air transportation from Los Angeles, includes U.S. departure tax. Scheduling, taxes, government fees and regulations are subject to change without notice and may increase tour cost.

HOTELS: Deluxe as indicated in the itinerary, based on two persons sharing room with private bath and/or shower. Executours Travel reserves the right to substitute hotels in comparable categories. **Please note:** *Logos and Executours Travel are not responsible for any hotel or airline arrangements made by tour members or third parties.*

SINGLE ACCOMMODATIONS: Although Executours Travel will attempt to arrange for a roommate if requested, this cannot be guaranteed. The single supplement charge is \$1,249. Both are subject to availability.

MEALS: All breakfasts and dinners (excluding beverages) in Turkey are included, unless otherwise noted on tour itineraries. Lunches are self-hosted and the tour member's responsibility.

TRANSFERS: Group transfers are provided in conjunction with our tour flights to/from group hotels. Tour members arriving and/or departing via other arrangements will be charged for individual transfers, if provided. Local transportation other than group transportation specified on the itinerary is the responsibility of the tour member.

SIGHTSEEING/TRANSPORTATION: All sightseeing tours described are provided by motor coaches or other vehicles depending upon circumstances at the time of tour operation. Air-conditioned vehicles will be provided where available and appropriate. Boats and feluccas may be included on some excursions. Entrance fees to places listed in the itinerary are included.

LUGGAGE LIMITS: Touring limits each person to 1 checked suitcase (not to exceed 50 lbs), 1 camera case or purse and 1 carry-on bag (not to exceed 18 lbs.) such as a backpack.

GRATUITIES AND TAXES: All local/government taxes on hotels, meals and services listed in the itinerary are included in addition to normal gratuities to the guide and bus driver. Post-booking increases in such taxes and fees will result in surcharges.

CANCELLATION PENALTIES & REFUNDS: *The REFUND/CANCELLATION POLICY is set forth on the first page. If the tour member cancels the tour in full compliance with the REFUND/ CANCELLATION POLICY on the first page, then the refundable portion of sums paid to Executours for services not provided (less all deductions provided for in the POLICY and/or this registration form) will be promptly refunded unless the tour member otherwise advises Executours in writing. Any additional costs, change fees and penalties charged by airlines or vendors for cancellations or changes are the responsibility of the traveler and may be deducted from any refund otherwise due.*

UNUSED/NO REFUNDS: There are no refunds for unused services, airline tickets or portions of the tour not taken. No refunds will be made to tour members who do not complete the tour or any part of the tour for any reason.

LOSSES/INJURIES: Logos Educational Corporation, Logos Ministries and Executours Travel are not responsible or liable for loss, damage, or theft of personal baggage and belongings and are not liable or responsible for personal injury, accident, or illness from any cause, including negligence.

VISA: A visa is required for this tour for Turkey for U.S. citizens, and the visa fee is included. Non-US citizens must make their own separate arrangements for visas and Executours is not responsible for applying for such visas. Passports must be valid for at least six months after return date.

HEALTH: Tour members should consult their personal physician for individual assessments and recommendations. Each tour member certifies that he/she is fully fit and able to participate in the tour and all related activities and has no physical, mental or emotional condition that would create a hazard or detract from the tour for him/herself or other passengers.

NO SMOKING: This is a nonsmoking tour. Smoking is not permitted in aircraft, vehicles, anywhere the group is gathered, or where prohibited by local law or hotel/carrier/vendor policy.

CHANGES: Although Logos Educational Corporation, Logos Ministries and Executours Travel will use reasonable efforts to adhere to the printed itinerary, it may be necessary to adjust or change arrangements or to eliminate, shorten, or limit certain aspects of the itinerary as circumstances warrant. Changes or deletions also may be made by air carriers, or other operators/providers. Logos Educational Corporation, Logos Ministries and Executours Travel also reserve the right to cancel the tour before departure.

REMOVAL FROM TOUR: Logos Educational Corporation, Logos Ministries and Executours Travel reserve the right to decline or remove any person from participating in all or any part of the tour, before departure or during the tour, should in their sole judgment such person's physical, mental or emotional health, behavior or general deportment create risks to health or safety, tend to impede or affect the normal operation of the tour, or impose on the rights or comfort of other tour members or fellow passengers. The decision to remove any person from the tour will be at the sole discretion of the tour leader. All costs associated with removal will be the responsibility of the person/persons removed. No refunds will be provided for persons removed from any part of the tour.

Unforeseen conditions may necessitate tour changes and the right is reserved to make such changes as deemed advisable by the tour leader. Tour members voluntarily assume full responsibility for all risks of travel and of participating in the tour; have been advised to obtain appropriate travel insurance or other insurance; and hereby release Executours Travel from any duty of checking or verifying any and all passport, visa, vaccination or entry requirements and all safety or security conditions of any tour destination or the tour itinerary. Participating in the tour constitutes acceptance by the tour member of all above noted terms and conditions and risks and releases Logos Educational Corporation, Logos Ministries and Executours Travel, and their affiliates, officers, employees, and designees from any and all known and unknown claims and liabilities.**

TCRF: This transaction is covered by the California Travel Consumer Restitution Fund (TCRF) if the seller of travel was registered and participating in the TCRF at the time of sale and the passenger is located in California at the time of payment. Eligible passengers may file a claim with TCRF if the passenger is owed a refund of more than \$50 for transportation or travel services which the seller of travel failed to forward to a proper provider or such money was not refunded to you when required. The maximum amount which may be paid by the TCRF to any one passenger is the total amount paid on behalf of the passenger to the seller of travel, not to exceed \$15,000. A claim must be submitted to the TCRF within 12 months after the scheduled completion date of the travel. A claim must include sufficient documentation to prove your claim and a \$35 processing fee. Claimants must agree to waive their right to other civil remedies against a registered participating seller of travel for matters arising out of a sale for which you file a TCRF claim.
